She is also a member of Childhood Cancer International – Europe's Regional Committee and plays an active role in their European Affairs as well as Research & Innovation Pillars. She is the (step)mother of four boys, one of whom died of cancer in 2024 at the age of 20 after 11 years of treatments. It was the lack of innovative treatment options available to her son that motivated her and her family to establish KickCancer. Prior to founding KickCancer in 2017, Delphine had a career as an international corporate lawyer, strategy consultant, and legal advisor to private investment funds dedicated to renewable energy.



**Enrique Terol**
